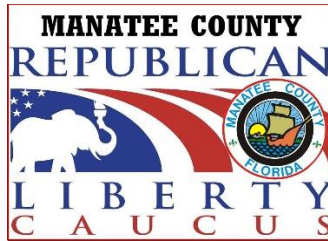

### Manatee County School Millage Referendum

*Shall the School Board of Manatee County  
continue the current 1 mill ad valorem  
millage from July 1, 2025, through June 30,  
2029? **NO, against continuation***

- Voter Registration Deadline: Monday, October 7, 2024
- Deadline to request a Vote by Mail ballot to be mailed: October 24, 2024
- Early Voting: October 21 through November 2, 2024, 8:30 am to 6:30 pm
- Deadline to return Vote by Mail ballot: November 5, 2024 by 7:00 pm
- Election Day: November 5, 2024 Polls open 7:00 am - Polls Close 7:00 pm

You will have other Republican candidates listed on your ballot. Our members and you will choose to vote in those races. Those candidates and ballot issues listed above are only those that passed the threshold for the RLC. Donald J Trump is the only national candidate on your ballot endorsed by the National Republican Liberty Caucus. None of the state candidates endorsed by the Republican Liberty Caucus of Florida appear on your ballot. Only those local candidates endorsed by the Manatee County Republican Liberty Caucus appear here. Others chose not to apply. It takes 2/3 vote of our members to endorse and if our candidate loses in the primary we do not consider an opponent in the general election. Manatee Patriots published a Voters Guide with all Republican candidates or Republican appointees listed and we invite you to consider it in making your REPUBLICAN vote in the 2024 General Election.
